COMBINING SPEECH LANGUAGE THERAPY, OCCUPATIONAL THERAPY AND MENTAL HEALTH THERAPY, CHILDREN ARE SUBMERGED IN A RELATIONSHIP BASED LEARNING ENVIRONMENT TO REMEDIATE THE SIGNIFICANT IMPACT OF TRAUMA, ABUSE AND NEGLECT ON THE DEVELOPING BRAIN. ON AVERAGE, CHILDREN IN THIS PROGRAM HAVE EXPERIENCED 5 DIFFERENT TYPES OF TRAUMATIC EVENTS. THE AVERAGE LENGTH OF TREATMENT IS 15 MONTHS FOR CHILDREN TO IMPROVE AND GRADUATE WITH MENTAL HEALTH AND DEVELOPMENTAL SCORES WITHIN TYPICAL RANGES. 59% OF CHILDREN SERVED WERE MALE, 41% FEMALE OF WHICH 44% WERE AFRICAN AMERICAN, 25% CAUCASIAN, 7% HISPANIC AND 24% MULTI-RACIAL.
